## IAPS Squash Championships

### Booking onto an event

- All bookings are made online via the [IAPS website](#).
- Only a member of school staff with a school email address can book onto an event.
- If the event is full, please join the waiting list. Should a space become available, we will contact you to offer you the space. There is no guarantee we can find schools a place.

### Entry eligibility

- All competitors must attend an IAPS School.
- Competitors ages is taken from 1st September.
- Competitors can only participate in one age group throughout the competition. The competition is defined as both qualifying events and the finals.
- Unless otherwise specified, schools can only enter one team per tournament/championships.
- Only competitors who are part of the Prep School are eligible to take part. Competitors in Year 7 and Year 8 who are part of the Senior School are not eligible to take part in U13 events.
- All schools must bring first aid.

## IAPS Squash Championships

### Event information

#### Girls' competition

- Subject to how many competitors take part, Girls can either take part in one or both the U11/U13 and girls' competition.
- If we receive a good number of girl entries into the girls' competition we might have to ask competitors to take part in either the girls or the U11/U13 competition.

#### Event programme

- The programme and event day information will be sent to schools approximately two weeks before the event.
- School will be asked to provide competitor details before attending the qualifier. In line with GDPR, only essential information is collected in order to be able to organise the sports event.

#### Draw/ Schedule

- The draws are created by the organisers and IAPS after the closing date and will share with the organisers as soon as possible.

### Marking matches

- Competitors are required to mark the matches.
- The winner of each match is responsible for returning the match score sheet to the competition control desk so that the result can be recorded.

U11 singles (mixed)  
U13 singles (mixed)  
Girls' singles

#### Championship format

The competition starts with pool matches followed by knockout competitions (cup and plate).

All competitors are required for both days.





## IAPS Squash Championships

- The winner should then collect the score sheet for the following match and return to the relevant court to 'mark' the next match.
- Competitors should be 'coached' on how to mark matches prior to attending the event.

### Para sport

### Equipment

- Competitors should wear non-marking shoes.
- British Standard eye protection is required for all matches.
- The double yellow dot ball will be used.
