- How the digital landscape has dramatically changed accessibility to harmful content.
- The main influences in our young people's minds that shape their attitudes

• The science of addiction and brain chemistry with regard to online p\*rn consumption • The qualities that feature in healthy relationships - not just the VERY base line of consent, but love, respect, trust and intimacy - all of which are absent on most easily accessible p\*rn sites.

• Language we can use with pupils, staff and parents

• How to engage parents and carers in these tricky topics.
