The role

Consultants will be required to:

Recommended qualifications:

- Accreditation through University of Buckingham – See application procedure
- Enhanced DBS check

Range of experience that will be desirable in delivering the services:

- Knowledge and understanding of the independent preparatory school sector
- Experience as a senior leader or manager in schools
- Experience as a corporate senior finance officer
- Experience as an educational/financial consultant

In delivering the services, consultants may be required to:

- Examine and interpret complex issues
- Speak and present confidently in group settings
- Have excellent verbal and written communication skills
- Build strong, trusted client relationships

You will not be expected to have experience in all areas. Consultants will have the opportunity to highlight individual areas of expertise and interest on the application form.

Stage 1 - Application

Please fill in and return the application form.

Stage 2 - Accreditation

To ensure the highest standards of consultancy, all applicants must undertake an accreditation qualification, via the University of Buckingham. The cost of accreditation is £409, payable on application. Applicants will be required to attend the University of Buckingham for one day, either in person or online.

Closing date

We are looking to establish a large team to offer instant services to our schools. We are happy to consider applications to join the team at any time.

Contract

Consultants will not become employees of IAPS but instead be Freelance and appointed on a 'For Services' contract as and when schools request relevant consultancy. The amount of work offered will vary depending on demand, but we would hope to engage our consultants each term. Consultants will be engaged for a maximum of 5 years and will be required to have individual business insurance.
